ULB NAME: Nagar Panchayat Dhandera

Part I - Notes to the Balance Sheet

- i. The Contractual liabilities not provided for:
 - a) Amount of contracts entered on account of capital works but on which no works has commenced.
 - b) In respect of claims against the ULB, pending judicial decisions.
 - c) In respect of claims made by employees.
 - d) Other escalation claims made by contractors.
 - e) In case of any other claims not acknowledged as debts.
2. Nagar Panchayat Dhandera was incorporated as on 23/07/2021 vide UDD notification no. 1165/IV(3)/2021-2 (N.P) dated 23/07/2021 by merging therein Gram panchayats Dhandera".
3. We have shown no assets and liabilities in the OBS as on 23/07/2021, in its support we are relying on the letter dated 12/06/2023 shared to us by ULB which is clearly stating that no assets and liabilities were got transferred on the date of incorporation (i.e 23/07/2021).
4. As on 10/09/2021, charge for some records and assets was transferred to Nagar Panchayat Dhandera by Gram Panchayat as per charge list, description and person having controls for records and assets is clearly mentioned in the letter dated 12/06/2023 shared to us.

Part II - Significant Accounting Policies

1. Fixed assets have been valued at historical cost wherever records were available. In case an asset has been created out of grants, the gross value of the asset has been shown as assets and the corresponding grant as liability, as proportionately reduced by depreciation.
2. Depreciation has been provided on straight line method by estimating the useful life of the asset.
3. Long term investments have been valued at cost.
4. Stores and spares have been valued at cost. In determination of cost, weighted average method of costing has been used.





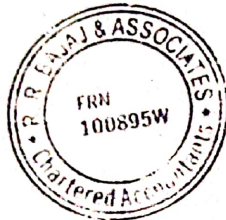
5. In calculation of arrears of property tax, arrears which relates to sick and closed industries 100% provision has been made on an individual basis.
6. Arrears of rental income from municipal properties have been accounted for as done for property tax. No accrual of revenue has been done for other receivables.
7. Valuation of current investments has been done on cost.
8. The difference between assets and liabilities has been recognized as the opening balance of Municipal General Fund or as Capital Deficit.
